Sub: Collection of Toll Charges on containers and other cargoes passing through JN Port.

In order to decongest the port and port area roads, it was decided in April, 2016, that the existing Toll Plazas will be discontinued from the roads of NH-4b and SH-54 and toll charge be collected only from the port related traffic. It is in line with then policy that the road network under JN Port was created to cater to JNPT port traffic. This step will help in redressing the grievance of the local commuters and also help in smooth flow of traffic on these roads. It is decided by the government and NHAI that toll/user fee will be collected by JNPT on port related traffic at its Gate Complexes till repayment of toll debt liability.

In view of this decision, toll will be levied on Port's goods traffic using the road connectivity. The following toll charges will be levied in view of the TAMP's direction dated 29.04.2016 and as further revised TAMP's order dated 15-Sep-2017, on containers (TEU) and other general cargoes going in and out of all Gate Complexes (i.e. at JNPT, NSICT, GTI, NSIGT & BMCTPL) and BPCL from Shipping Lines/Agents/Tank Farm Operators delivery by road/ consignees, etc., other than the rates specified under approved Scale of Rates:
