I. COMPANYPROFILE:

India Ports Global Limited (IPGL) is incorporated on 22 January, 2015 under the Companies Act, 2013, as per directions of Ministry of Shipping (MoS), Government of India for development of Ports overseas. The Ministry of Shipping has presently assigned IPGL the task of equipping and operation of Container / Multi-purpose Terminals at Chabahar Port in Iran.

II. JOB DESCRIPTION ANDRESPONSIBILITIES:

The Deputy Manager (Finance& Accounts)/ Manager (Finance& Accounts) will be responsible for all Finance/Account matters and will report to the Director (Finance)/CFO / Managing Director. His functions shall include:

- (d) Persons having similar qualifications and experience in a reputed private sector organization with presently drawing a total CTC of Rs. 10 Lacs P.A. /12 Lacs P.A.

Officers of appropriate level/rank, retired from Major Port Trust or Central/State Govt./PSUs with Port/Shipping experience, may be considered, if found suitable. In such a case, relaxation in qualification, age and experience shall be considered, depending upon their experience in the related field, and appointment shall be on contract basis, with lump sum monthly emoluments commensurate with their qualification, experience and last pay drawn.
