## TRADE NOTICE

This is in continuation to the Trade Notice issued by JNPT on 24.03.2020 read with addendum issued on 26.03.2020. In view of lock down period extended by Govt. up to 14.04.2020, Ministry of Shipping vide order letter dtd 31.03.2020 has issued following directives to all Major Ports:

- (i) In the light of the MHA order No. 40-3/2020-DM-I(A) dated 25.03.2020 and by invoking power under section 53 of Major Port Trust Act 1963; each Major Port shall ensure that no penalties, demurrage, charges, fee, rentals are levied by the Major Ports on any Port user (traders, shipping lines, Concessionaries, Licensees etc..) for any delay in berthing, loading/unloading operations or evacuation/arrival of cargo caused by the reasons attributable to lockdown measures from 22<sup>nd</sup> March to 14<sup>th</sup> April 2020.
- (ii) Therefore, each Major Port shall except or remit demurrages, ground rent over and above free period, penal anchorage/berth hire charges and any other performance related penalties that may be levied on Port related activities including minimum performance guarantee, wherever applicable.


View of the above, the following waiver/remission/relaxations are extended by JNPT from 22.03.2020 to 14.04.2020 for JNPCT:

- a) No dwell time charges will be levied for all import / export containers moved by Road and Rail (CFS/DPD/Empty/ICD).
- b) No shifting charges for change of mode (ie Truck to Rail or Rail to Truck) subject to receipt of NOC from shipping lines for change of mode.
- c) Delivery of DPD containers will be allowed from JNPCT Terminal after 48 hrs also (for two more days after 48 Hrs ie up to 96 hrs) in case documents ie online Custom out of charge, e-DO & Stamp Duty challan are received based on the specific request of importer. No shifting charges will be levied for DPD containers delivered directly to importers after 48 Hrs.

The aforesaid relaxations should not impact or dilute the day to day operations and evacuation of containers from Terminal.

Accordingly all stake holders shall make efforts to continue operations in all respects in true spirit of the above guidelines by the Government and ensure to pass on the benefit of the above relaxations to the end users.
