Sub: Extension of validity of existing tariff towards levy of Mandatory User Charge (MUC)

Please refer to our earlier Trade Notice No. JNP/CM(F)/Public Notice/2018 dated 31.03.2018 regarding levy of Mandatory User Charges (MUC) of ₹145/- (plus GST) for the F.Y. 2018-19 for all the containers entering and exiting the five terminals of JNPT for Logistics Data Bank (LDB) project. The validity of the existing tariff of MUC is getting expired on 31st March 2019.

Tariff Authority for Major Ports has, vide Notification no. TAMP/46/2018/-MUC dated 28th February 2019 has extended the validity of the existing tariff for levy of MUC for a period of three months beyond 31st March 2019 i.e. from 01st April 2019 to 30th June 2019 or till the effective date of implementation of new tariff to be fixed for levy of MUC based on the proposal filed by DMICDC, whichever is earlier.

The MUC will be collected for all the containers entering and exiting the all the five terminals of JNPT at the rate mentioned above for the extended time as mentioned in para 2 of this Trade Notice.
