### Sub: Billable activities performed during Inter Terminal Transfer of transshipment of containers between JNPT and BOT operators

In order to eliminate discrepancies such as different charges applied for services rendered by JNPT for the Inter Transshipment Container handled for M/s NSICT or M/s GTI. Revised rates for Inter Transshipment Container have been made applicable for all BOT Operators i.e. one shifting charge plus normal Transshipment charges in case of discharge/loading of a Inter Terminal Transshipment container to/from JNPT and all the BOT operators which is worked out to Rs. 2629/- per 20' container (50% of Transshipment Rate + Lift on/Lift Off) as per existing Scale of Rates.

Revised rates are as follows:-

- (i) When container discharged by JNPT and loaded by any of the BOT operators namely M/s NSICT, NSIGT, GTI & BMCTPL then Port will levy charges as calculated below for 20' container:

- (ii) When Container is discharged by any of the BOT operators namely M/s NSICT, NSIGT, GTI & BMCTPL and loaded by JNPCT then Port will levy charges as calculated below for 20' container:

Thus, Port will collect only Rs. 2629/- as per current Scale of Rate for container loaded by Port and discharged by any of BOT operators.

The above charges are calculated based on TAMP approved Scale of Rate dtd 19.05.2014, which is currently being applicable for JN Port. Though TAMP has notified Tariff on 24.01.2017, it is not implemented in JNPCT for Container Related Charges (CRC).

All Port Customers/BOT operators are requested to take note of the above.
