### **Sub : Opening of PD account and Collection of DPD charges.**

In accordance with PN-57/2018 issued by Jawahar Customs, it has been decided to transfer DPD containers not picked up by importers within 48 hrs of landing to any of the CFS as nominated by concerned Shipping Agency in Import Advance List (IAL).

As per Trade Notice no: JNP/Fin/R-CT/2017, dtd. 12.09.2017, DPD charges to the tune of Rs.1,688/-+ GST for 20' container and Rs.2,532/- +GST for 40' container along with ground rent charges at actuals are payable by importers for DPD containers. In addition to this, one Shifting charge (Rs 2023/- + GST for 20" container and Rs 3034.5/- + GST for 40' container) towards change of destination is also applicable for such containers.

JNPT will collect the aforesaid charges from the concerned CFSs in respect of DPD containers moved to their CFS beyond 48 hrs. These charges are to be collected by the nominated CFSs from their importers at the time of delivery.

For the purpose of collecting charges by JNPT, all CFSs are required to open a PD account with JNPT with a minimum balance of Rs 1 lakh and maintain sufficient balance in their PD account/s to avoid deactivation.

Please note that the CFS code (like GDL, AGL...) will be the PD account number and CFSs need to transfer payment to that account through PCS only. For this purpose CFSs are requested to get registered with PCS through 'stake holder registration' option available on [www.indianpcs.gov.in](http://www.indianpcs.gov.in).

The above procedure will come in to force with effect from 17.12.2018 by which time CFSs shall be ready with their PD accounts without fail.
