**Subject – Fuel Adjustment Cost (FAC) to be billed in the month of September 2024.**

**Reference – Maharashtra Electricity Regulatory Commission (Multi Year Tariff) Regulations, 2019**

As per MYT Regulations, 2019 approved by the Hon'ble Commission, Fuel Adjustment Charge (FAC) is applicable every month in electricity bill of the consumer. Accordingly, FAC to be levied to consumer of JNPA-SEZ in the billing for the month of **September 2024** is as follows –
