Jawaharlal Nehru Port Authority (JNPA) Celebrates World Environment Day 2024 with Mega Tree Plantation Drive

Mumbai, June 05, 2024 – The Jawaharlal Nehru Port Authority (JNPA), India's premier container handling port, celebrated World Environment Day with great enthusiasm and a strong commitment to sustainability. The event, held on Wednesday, June 5, 2024, featured a series of activities aimed at promoting environmental awareness and action. Their initiatives include the ambitious transition from diesel-powered trucks to zero-emission electric vehicles within the port premises over the next five years. Moreover, trucks and vehicles in the Vadhvan mega-port will be diesel-free from the start. This shift aims to drastically reduce air pollution and aligns with India's national sustainability goals. Additionally, JNPA actively incorporates



renewable energy sources for terminal operations and promotes extensive green cover, with nearly 34% of the port area dedicated to mangroves and other plant life.

The World Environment Day celebrations at JNPA were a significant step towards fostering a culture of environmental responsibility and action among its stakeholders. The event underscored the importance of preserving and restoring our natural environment for future generations.

Currently, JNPA operates five container terminals -- NSFT, NSICT, NSIGT, BMCT and APMT. The Port also has a Shallow Water Berth for general cargo. A Liquid Cargo Terminal which is managed by the BPCL-IOCL consortium is also there at the port along with a newly constructed coastal berth.

Nestled across 277 hectares of land, JNPA also operates a meticulously designed multi-product SEZ, with state-of-the-art infrastructure, to boost export-oriented industries in India.
